The Committee takes note of the launch of the first calls for expression of interest, information concerning coordination of NDICI and INTERREG funding, as well as information concerning communication.

#### 2.2 Membership of Sri Lanka

The Committee unanimously approves membership of Sri Lanka to the Interreg VI Indian Ocean program. The Managing Authority will submit a request for modification of the program to the European Commission in order for Sri Lanka to be officially included as a participating country to the program.

The Committee approves the assessment plan of the program.

## 2. Speech by Pierre-Emmanuel LECLERC (DG REGION – European Commission)

Mr Pierre-Emmanuel LECLERC (DG REGIO) would like to thank the Regional Council of Reunion for organising this Monitoring Committee during a very busy professional period.

To comply with the regulations, the Monitoring Committee has to meet at least once a year, preferably in person (as defined by the Rules of Procedure of the Monitoring Committee). It is important for the members of the Committee to meet once a year, to see each other and discuss. The topics for discussion are many and varied:

- 2014-2020: end of the programming period and preparation of closure
- 2021-2027: assessment of the first year and perspectives for the coming year
- After 2027: launching as from now an analysis of the future cohesion policy. What will be the future of the cohesion policy after this date? What will be the future of the INTERREG programs and more particularly the programs targeting the Outermost Regions?

Mr LECLERC uses the terms of the Commissioner for regional policy declared during the seminar held in Marseille in June to launch the French INTERREG programs: "There are no absolute barriers between programming periods."

As regards the closure of 2014-2020 programming period, the Commission would like to thank the Regional Council of Reunion for the work that has been both carried out and started, for at least the last year, with the aim of covering the cost of projects.

However, he should like to express our slight disappointment that, in view of currently available data, the program has only achieved 90% of the allocated funds, the more so as almost all the strands show a rate of achievement that is below 100%. In practice, therefore, it will appear impossible to apply flexibility on closure. We do, however, understand the attitude of caution applied by the managing authority, making it possible to obtain an estimate of cost of projects as close as possible to reality.

Unfortunately, the risk is that the decision-makers will retain the 10% that has not been spent, rather than the 90%. An analysis aimed at avoiding insufficient financing for current and future programs should thus be carried out.

Among this year's achievements regarding the launch of the 2021-2027 program, he should like to mention:

- Adoption of criteria for selecting projects, which made it possible to launch the first call for projects in October;
- Creation of an Internet page dedicated to the program, taking into consideration the new obligations under the Interreg regulations;
- Drawing up of an assessment plan;
- Transmission of financial data, with a focus on respect for regulatory provisions.

Concerning the assessment plan, he should like to express our satisfaction that the regulatory deadlines have been respected by the managing authority. He takes the liberty of making a few suggestions concerning the content of this plan:

- Involving organisations outside Reunion Island (notably European Union delegations: EUDs)
- Taking into consideration coordination and exchanges with programs managed by the EUD, notably the DG for International Partnerships.
- Introducing a plan for monitoring of recommendations for the assessment.

Another positive point: the progress made in your relations with our EUD colleagues and progress as regards coordination of ERDF funds and overseas policy.

While relations with the Mauritius EUD are well-established, those with the EU bureau in the Comoros and the Madagascar EUD, though also in existence for a long time, have been reinforced through regular and structured exchanges. A new element to note is the beginning of a collaboration with the EUD in Tanzania, which manages a cooperation programme in the Indian Ocean around blue economy.

He should also note the coordination with the regional program of the TAAF (in addition to the more classic cooperation program with intra-regional funds dedicated to the TAAF).

As regards coordination of funds, the results of the studies aimed at entrusting the funds to the French Development Agency are now available (ERDF under shared management and NDICI under indirect management). Even though the outcome has not been positive, what is important is that we have set off the process of analysis and explored all the possible solutions.

The perspective is now that of the transfer of an amount of NDICI funds from the regional "Sub Saharan Africa" program to the Indian Ocean Interreg program. This is a key period. The DG REGIO, which will manage these funds, will do everything possible to support the managing authority, enabling them to make a success of this experience, which is a true step in the right direction as regards quality.

However, there remains one point that has not been covered which is the composition of the pilot committee (for selection) of the program. The members of the selection committee represent the structures in Reunion and Mayotte, which is not acceptable for several reasons:

- The first reason is that the structure of the pilot committee must reflect that of the monitoring committee. In actual fact, that the monitoring committee includes partners of third countries, which is not the case of the pilot committee. There exists therefore a breach here which needs to be resolved.
- The second reason is that a key element of the INTERREG programs has always been associating partner third countries in the selection of projects. The INTERREG regulations cover and involve all partners concerned.
- Finally, all the INTERREG programs (90 in number), including those with external frontiers, and including those targeting the Outermost Regions, include third parties in the selection committees.

This issue has been raised several times with the managing authority. Up till now, the selection of projects has been carried out contrary to the Regulations of the program. It is quite clear that this cannot continue.

A final point concerns the period after 2027, for which an initial analysis has already been carried out. The programs will, on the one hand, consult their partners, and, on the other hand, the citizens. The Director of Cooperation at the DG REGIO wishes to specifically commit himself to the Outermost Regions. He is ready to is go out into the field, which he will do during the second half of March, and will find it useful to meet the appropriate partners. I should like to thank the services of the General Council in advance for the very warm welcome he will be given during this process.

## ANNEX 1: Opening speech by Mr Wilfrid BERTILE

#### **Opening speech by Mr Wilfrid BERTILE**

First of all, I'd like to once again greet you all and wish you a warm welcome. We are all here today for the monitoring committee of the European Interreg program, a European fund for territorial cooperation implemented by the territorial authorities. The Reunion Regional Council of is the managing authority for European funds of the Interreg program in Reunion. These European cooperation funds are used to finance cooperative projects set up in your countries, in partner countries and, since the latest programming, the different partner countries have been associated in the use of these funds through the Interreg monitoring committee, which is why we are meeting here today. I should therefore like to greet the representative here of the European Commission, Mr Pierre-Emmanuel Leclerc, regional rapporteur for the GD REGIO, who is thus in charge of application of Interreg programs, implemented from Reunion for the Indian Ocean program and from Mayotte for the Mozambique Channel program.

In the context of both our development policy in the zone and that of our cooperation policy, Europe has always been an important partner. From the start, Europe has supported developing countries through European development funds, now referred to as the NDICI, both in the context of national indicative programs as well as that of regional indicative programmes when these countries are grouped together within a regional integration body.

Interreg funds are thus another source of support from the European Union for regional cooperation and development. These cooperation funds are additional to EDF funds, now referred to as NDICI. Also, since the start of the 2000s, as I stated in my introduction, the Reunion Regional Council has been implementing these programs and has been the managing authority for these European funds. Since the early 2000s, these funds have seen an important increase, with 5 million Euros for the period of 2000-2006 being increased to over 60 million for the current period, for previous program and the one now being set up. The amounts have increased, as has the number of partners, and we now have a number of overseas partners outside the French Indian Ocean regions of Mayotte, the TAAF (French Southern and Antarctic Territories) and Reunion.

These funds have made it possible to support a large number of projects. For the period of 2014-2020, 264 were supported, to the benefit of all our partners.

This afternoon's work session will first of all consist in a review of the 2014-2020 program referred to as Interreg V, now coming to an end, as well as an overview of the progress of implementation of the Interreg VI 2021-2027 program. We will also discuss the inclusion of a new member, Sri Lanka, and draw up an assessment plan for the coming period.












#### Implementation of the program





#### Impact of the COVID-19 pandemic on the implementation of the program

 Periods of lockdown – 1<sup>st</sup> quarter 2020

*l'Europe* 

- Flights suspended 2<sup>nd</sup> quarter 2020
- Reopening of certain flights early 2021 with periods of compulsory isolation and compelling reasons to justify travel, in a context of new strains circulating in the IO zone.



- Prolonged time-frames for implementation of projects.
- Cancellation or postponement of certain payments, including missions and travel, which represent one of the main expenditure items of Interreg projects (particularly significant for 2021 and 2022, with important rates of decrease for projects programmed in 2019 and 2020, the application of which was greatly disrupted over two years)
- ISV Program particularly disrupted, as well as programs aimed at mobility of artists, students and high-school pupils.









## Measures taken by the managing authority to compensate for these difficulties and optimise the program's certification rates

- ⇒ Initial two-month postponement for implementation of projects to have been completed during the periods of lockdown.
- ⇒ Reinforced dematerialisation of Managing Authority services, making it possible to inform and treat applications during the periods of lockdown and curfew as well as organisation of project Steering Committees by visioconference or written procedure in order to maintain the programming rate.
- ⇒ Organisation of continuous monitoring of the beneficiaries by the instructing departments (regular assessments with pilots of projects the implementation of which was delayed, warnings concerning end of contract deadlines) and drawing up of a quarterly certification schedule followed by a monthly schedule until completion.

- ⇒ Regular meetings based on monitoring tools (dashboards) with instructing departments in order to detect delays and potential difficulties.
- ⇒ Drawing up of annual prospective implementation enabling readjustment of financial models in application of estimated remaining amounts until completion (final adjustment in December 2021).
- ⇒ Mobilisation of the mechanism proposed by the CARE regulations (temporary increase of co-financing rate of the programme at 100% during the 2021-2022 financial year), making it possible to release a prepayment in order to achieve the 2022 automatic threshold.
- ⇒ Programming in 2023 of operations with implementation deadlines that were compatible with the date of 31st December 2023.

In view of these works in general, the final estimated certification rate of the INTERREG V program is close to 90%.



#### Importance of coordination between the NDICI and ERDF

The European Outermost Regions programs cooperate with those of non-European states benefiting from funds of the <u>EU external policy</u> (formerly EDF, now NDICI).

Consequently, cooperation with these 'third-party' States of the EU necessarily implies coordination between these funds and the funds of the EU cohesion policy (ERDF-European Territorial Cooperation).

- > Joint funding on the increase (programming 2007-2013 and 2014-2020)
- Statutory evolution for 2021-2027 enabling integrated management of the two sources of funding





#### Approaches considered by the managing authority 1/3



- Indirect management of the NDICI by the FDA (approved body) and shared management of ERDF par the FDA (which would be the intermediary body benefitting from a global ERDF subsidy delegated by the Managing Authority of the Regional Council of Reunion)
- ➤ This 'combined' structure has been the object of a study piloted by the FDA and funded by the French Ministry of Overseas.







#### Approaches considered by the managing authority 2/3

- First conclusions of the study (mid-2023): not in favour of the application of this option in the Indian Ocean (different procedures for release of funds, adaption to software (synergies), high costs for FDA: training and recruitment of agents (linked to compulsory separation of study/certification processes).
- Continuation of the study (to be completed end 2023):
- Enhancement of working processes to be set up in the context of management of an NDICI amount by the FDA and management of ERDF-INTERREG by the Regional Council managing authority.
- Scenario of delegation of ERDF-INTERREG funds and of NDICI to the FDA by indirect management of a topic presenting a common interest.







#### Approaches considered by the managing authority 3/3

The perspectives of coordinating the Indian Ocean Interreg VI program and the MIP (NDICI) were presented in the Canary islands, in the presence of the GD REGIO and the managing authorities of the ORs during the seminars held on 19<sup>th</sup> and 20<sup>th</sup> October 2023 around the regional integration of the ORs.

⇒ A question was raised during this event concerning the possibility of the Managing Authorities of the Madera-Azores-Canaries and the Indian Ocean programs managing NDICI funds provided by the regional Sub-Saharan Africa MIP (with procedures of indirect management).

A meeting with the GD REGIO to discuss this possibility was held on 17<sup>th</sup> November of this year, piloted by the French delegation in Brussels. The managing authority was able to propose possibilities of coordinating topics with the regional MIP, referring to the study of the French Overseas Ministry.







#### FRAMEWORK OF ASSESSMENT PLAN

### REGULATORY OBLIGATIONS (art. 35 reg. n°2021/1059)

The Managing Authority must submit an Assessment Plan to the Monitoring Committee at the latest within one year following adoption of the INTERREG program.

The Managing Authority carries out assessments on the basis of one or several criteria: efficiency, effectiveness, relevance, coherence, added value of the EU.

An assessment of each program aimed at measuring its impact is to be carried out *on* 30<sup>th</sup> June 2029 at the latest.


